At the RSA District Meeting held in the Conservatory of the HWMC, our new RNZRSA National President Tony Hill, presented Murray with his award. It was a privilege to have Murray's wife Jill join us for the occasion.

On behalf of committee and members, I would like to thank Syd Worster for his production of the beautiful mahogany timber base for our Flame of Remembrance which is now positioned on the corner of the main bar in the HWMC. Our thanks also to Tony Bennett for doing the electrical connection. Thank you gentlemen, we appreciate your work. We presently recite the Ode on Wednesday evening at 1800hrs in the club main bar. Syd has also installed a drop box on the wall to the right of the RSA main office door. This box slot can be used for couriers and also for members to place membership payments or mail for action by Helen.



I would like to mention our Hamilton Cadet Forces and note the increasing numbers of cadets joining our three units, Army and Training Ship Waikato based in Hamilton and No 7 ATC Squadron at Te Kowhai Airfield. ## Australian Chief of Army Cadet Team Challenge 2025

This July, cadets from across Australia and our very own Army Cadet team from New Zealand converged on Kokoda Barracks, Canungra, Queensland for the Australian Chief of Army Cadet Team Challenge 2025 (CACTC25). Representing every Australian Army Cadets (AAC) region, alongside the Australian Navy Cadets, and Australian Air Force Cadets, and New Zealand Cadet Forces (NZCF), the event brought together the very best young leaders.

The challenge tested cadets in leadership, resilience, and teamwork through a series of demanding physical and mental tasks. From grueling field activities and long days in the bush, to the punishing obstacle and water courses at Kokoda Barracks, cadets demonstrated discipline, determination, and teamwork under pressure.

After several days of competition which included ten field challenges, two nights under the stars, and the final water-based obstacle course, the NZCF cadets emerged triumphant, claiming first place in the competition. The Australian Air Force Cadets secured second, and Headquarters AAC Tasmania finished third.

🥇 The Commander of the Australian Army Cadets, Brigadier David McCammon, presented the winning trophy on behalf of the Chief of Army, and also awarded the cadets a Gold Commendation, the highest achievement within the program. The result was a source of immense pride for the New Zealand contingent. Following the challenge, the New Zealand cadets continued their adventure with the visiting UK contingent. Their journey began in Canberra with a tour of the Australian Parliament House followed by time at Questacon which is The National Science and Technology Centre, and a moving visit to the Australian War Memorial, where cadets had the honor of laying a wreath at the Last Post Ceremony.

The second week took them across New South Wales, from the Australian Air Force Heritage Centre and Kapooka Army Recruit Training Depot, to Cowra's Japanese War Cemetery and a lap of Mount Panorama at Bathurst. Cadets also enjoyed lighter moments which included shopping at the famous Lolly Bug lolly shop to taking in breathtaking views at Scenic World, Blue Mountains.

The trip ended in Sydney, with cadets walking across the Harbor Bridge, visiting Manly by ferry, and taking in the sights from the Sydney Tower Eye. Along the way, bonds deepened between New Zealand, Australian, and UK cadets, strengthening international friendships and reinforcing the shared values of service and leadership.

"Our cadets did themselves proud, as well as NZCF and their units. There wasn't a single negative word said about them during the competition. They represented New Zealand with determination, humility, and teamwork, and the friendships built along the way will last a lifetime."

For the cadets, this was more than just a competition it was a test of character, a celebration of international camaraderie, and an unforgettable opportunity to grow as leaders.

# Making medical check-ups easier for Vietnam veterans' annual medical assessments

**Vietnam veterans and their GPs now have an online form to help them with their annual medical check-ups.**

Vietnam veterans are entitled to a free annual medical check-up (AMA) with their GP. This entitlement is one of the provisions in the Memorandum of Understanding the Crown signed with Vietnam veterans in 2006, to recognise that they had served in a toxic environment and could have been exposed to chemicals such as Agent Orange.

In the past, Veterans' Affairs would send an AMA form to eligible veterans each year for them to take to their appointment, then the veteran would be required to send it back to us.

An online version of the AMA form is now available on the GP's patient management platform. GPs can complete the form online during the appointment, and no hard copy has to be provided by the veteran or returned to Veterans' Affairs. The GP can do it all online.

GPs can also attach other relevant material, like X-rays, with the assessment. From now on, the only veterans who still need to use a hard copy for their AMAs are those who live overseas, whose GPs won't be able to access the online system.

## Introduction to Qualifying Service

A question that is often asked of a Local Support advisor is: do I qualify for help?

**FYI. Here is what can be found on the Veterans affairs Web site.**

Qualifying Operational Service is a term used to describe service that has been carried out in areas that have been assessed as having environmental or operational risks to Defence Force personnel that is significantly greater than those of peacetime activities

There are two types of Qualifying Service:

- Qualifying Routine Service
- Qualifying Operational Service.

You don't need both types of Qualifying Service to get support. Either type will give you eligibility.

The support you can get depends on your unique service, including:

- where you served
- when you served.

You will also need to meet the individual requirements for each service or entitlement.

### Qualifying Operational Service

You will have Qualifying Operational Service if you have deployed to an area that has been declared as Qualifying Operational Service.

#### How Qualifying Operational Service is determined

An operation is determined "eligible" based on its assessed threat level.

1. After the decision to deploy has been made, the Chief of Defence Force must give a report to the Minister for Veterans as soon as possible. This report assesses the operational and environmental threats to deployed personnel. Deployments that have already ended can also be reviewed.
2. The Minister for Veterans decides if there is a significant risk of harm to deployed personnel.
3. The Minister for Veterans declares the operation as Qualifying Operational Service if it meets the threat threshold. This declaration is published on the Veterans' Affairs website.

If you don't have Qualifying Operational Service — and didn't serve before 1 April 1974 — you are likely not eligible for support from Veterans Affairs.

There is a chance that you have deployed on an operation that has yet to be declared as Qualifying Operational Service. Check the Veterans Affairs web site.

If you served before 1 April 1974 — regardless of where — you will have Qualifying Routine Service.

### Qualifying Routine Service

You will have Qualifying Routine Service if you served in the NZ Armed Forces before 1 April 1974 — either in New Zealand or overseas.

Qualifying Routine Service recognizes that before 1 April 1974, service members were not covered for work-related injuries or illnesses. Because of this, we provide support to all those that served in the NZ Armed Forces during this time.

Qualifying Routine Service stopped on 1 April 1974 with the introduction of ACC. Since that date, ACC provides support for all New Zealanders who suffer work-related injuries or illnesses. This coverage extends to members of the NZ Defence Force or NZ Armed Forces.
